The complaint in this action was filed on March 30, 2010, and the initial fee request was not filed until April 1, 2010. The Amended Application seeks \$1,982.50 for additional fees incurred between April 8, 2010 and August 2, 2010. Plaintiff has not submitted a timely motion requesting additional fees for this period of time. The Court therefore concludes that Plaintiff is not entitled to additional fees for this period of time, or for his request for fees of \$575.00 for the attempted service of the subpoena on Dr. Li, the minor Plaintiff's treating physician, or for the costs of the depose of Dr. Li.[1] The fees requested for Plaintiff's attorney for the period of March 30, 2010 to August 2, 2010 are reasonable and are therefore allowed. To the extent that Plaintiff is requesting additional attorney's fees for the period of January 12, 2010 to January 16, 2010, additional fees for the period of January 19, 2010 to January 30, 2010, and additional fees for the period of February 3, 2010 to February 18, 2010, the Amended Application is denied. The Court does not find that the hourly rates requested for services rendered in those periods are reasonable. 2. Fees Requested for the Initial Request for Fees Plaintiff seeks fees for the first request for fees in the amount of \$43,617.50 for his work on the case up to March 8, 2010. The Court finds the request for fees for this period of time to be reasonable. The fees requested for Plaintiff's attorney for the period of March 9, 2010 to April 30, 2010 and May 4, 2010 to May 16, 2010 are reasonable. The fees requested for Plaintiff's attorney for the period of June 2, 2010 to June 7, 2010 are reasonable.
